TO PATIENT:

Fairway Medical has financial relationships with a number of Physicians, some of whom have an ownership interest in the Hospital, and some of whom are paid by the Hospital for services they provide.

You will not be treated differently by your physician if you choose to use a different facility. If desired, your Physician can provide information about alternative providers.

If the physician who recommended the Hospital to you is on the list below and if his or her financial relationship with the Hospital concerns you, you may be treated at an alternative facility if there is one available. If you would like to discuss your options for treatment at other facilities, or if you have any questions about this disclosure, please ask the person providing you with this form for assistance.

DISCLOSURE OF EMERGENCY RESPONSE PLAN:

Fairway Medical has arranged for one or more physicians to be on-site at the Hospital and available to respond to medical emergencies. However, we cannot guarantee that a physician will be present at the Hospital at all times. In the event of an emergency, the nursing supervisor and Anesthesiologist are on call and readily available. All registered nurses in the facility are required to be BLS (Basic Life Support) certified and per job description may be required to be ACLS (Advanced Cardiac Life Support) and PALS (Pediatric Advanced Life Support) certified in order to identify and respond to emergencies. In addition Fairway Medical has emergency equipment necessary to provide care per ACLS protocol. Should a situation arise that requires transport, Fairway Medical will call Acadian Ambulance or emergency services to arrange transport to the nearest facility available.
